

Veterans of Foreign Wars Post Rental Rules

Thank you for choosing our home for your celebration

Please abide by our simple rules.

1. No functions for Personal Gain such as Tupperware or Jewelry, or anything for profit to the person renting the Post.
2. No more than 60 People in attendance.
3. No loud music - a single complaint will get the event shut down without refund.
4. No drinking without obtaining an ABC license, and no drinking allowed outside of the building.
5. No underage drinking at any time - or any violation of law.
6. All parties will be over by 11:30 PM.
7. The person renting the post will be responsible/liable for the Post and the actions of all the guests.
8. The person renting the Post to leave the post and the kitchen clean, and remove all of the trash from the Post.
9. The cost of renting the post is \$150 in total with a \$100 dollar deposit payable upon scheduling. The remaining \$50 is required by the day of the event.
10. The cost for renting the post is \$75 for members.
11. There will be no charge for the VFW or auxiliary members that are serving a meal for the family of the departed number.
